AUS-MEAT is dedicated to safeguarding the privacy of individuals in accordance with the Australian Privacy Act 1988. 1. Collection and Use of Personal Information: Personal information may be collected by AUS-MEAT during the regular course of business. 2. Personal information may be disclosed to our service providers confidential for the sole purpose of conducting the NFAS program or as specified in the NFAS Rules.
3. Exceptions to Disclosure: Under specific circumstances, such as a legal requirement, emergency situation, unlawful act or omission, or otherwise exceptional circumstances, the Chairman of AUS-MEAT or their nominee may, at their discretion, authorise the release of personal information.

4. **AUS-MEAT Privacy Policy:** The collection, use, and disclosure of personal information by AUS-MEAT Limited is governed by the AUS-MEAT privacy policy. This policy ensures that our practices align with the Australian Privacy Act.
